





### FAQs

- Q: Are we eligible for pre-award costs for the TCLAS award?
   A: Yes; Awards from the ESSER III funding source have allowable pre-award beginning 3/1/2021. Awards from General Revenue pre-award is allowable beginning 9/1/2021.
- Q: I have questions about the specific support(s) I was offered. What should I do? A: Attend the upcoming support-specific webinar!
- 3. Q: We weren't awarded our full request through TCLAS. Can you explain how this might happen?

A: Awards were prioritized based on the award methodologies and priority points for each decision point. Three main scenarios for this happening are that the LEA might not have met the prerequisites required for award, the vendor might have reached capacity, or the budget was exhausted.

4. Q: We applied for a decision, but only received a **partial award**. Now, we're less interested. What are our options?

A: Districts in this situation may continue with their partial award so long as they can still meet program assurances or they may choose do decline the award.
