Context: CCMR Outcomes Bonus

- Under House Bill 3 (HB 3), 86th Legislature, 2019, the agency awards districts CCMR Outcomes Bonus funding.
- [TAA from April 11](#)
- Funding is awarded based on the number of annual graduates who demonstrate college, career, or military readiness in excess of a threshold for three cohorts
 - annual graduates who are economically disadvantaged;
 - annual graduates who are not educationally disadvantaged; and
 - annual graduates who are enrolled in a special education program.

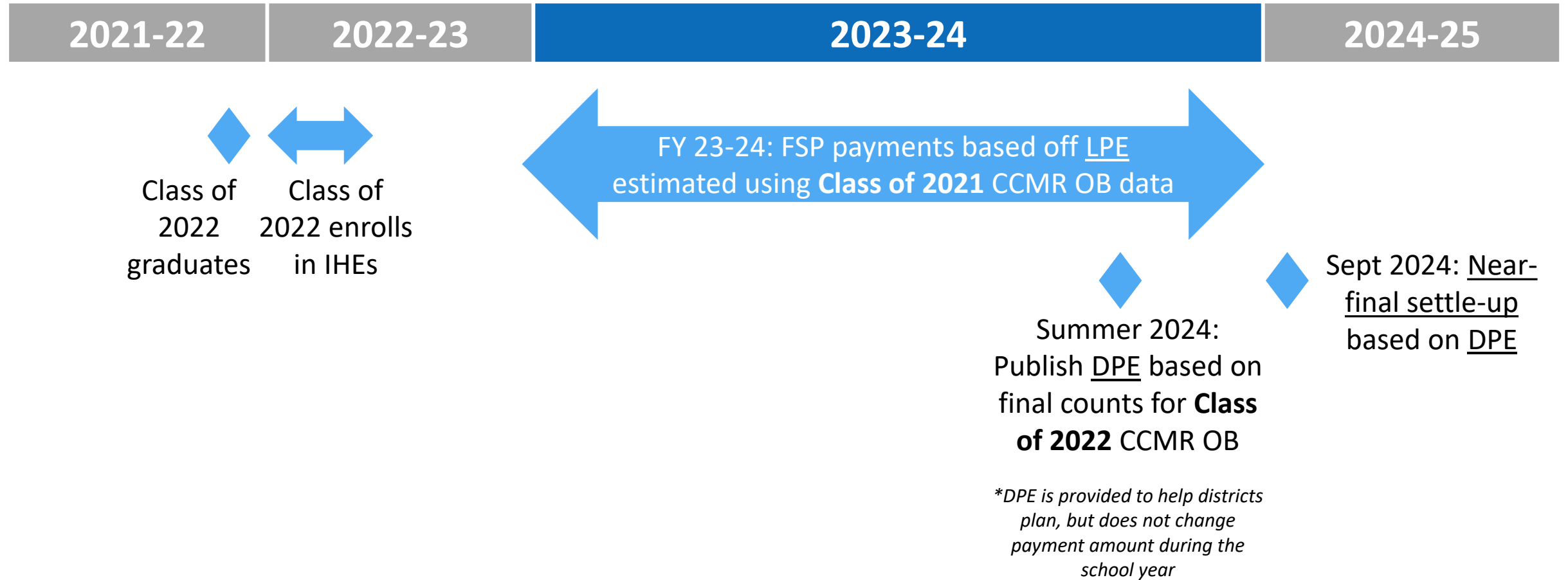
College ready in CCMR OB is defined as:

- Earns an associate degree, or
- Meets Texas Success Initiative (TSI) criteria and enrolls at a postsecondary institution immediately following high school.

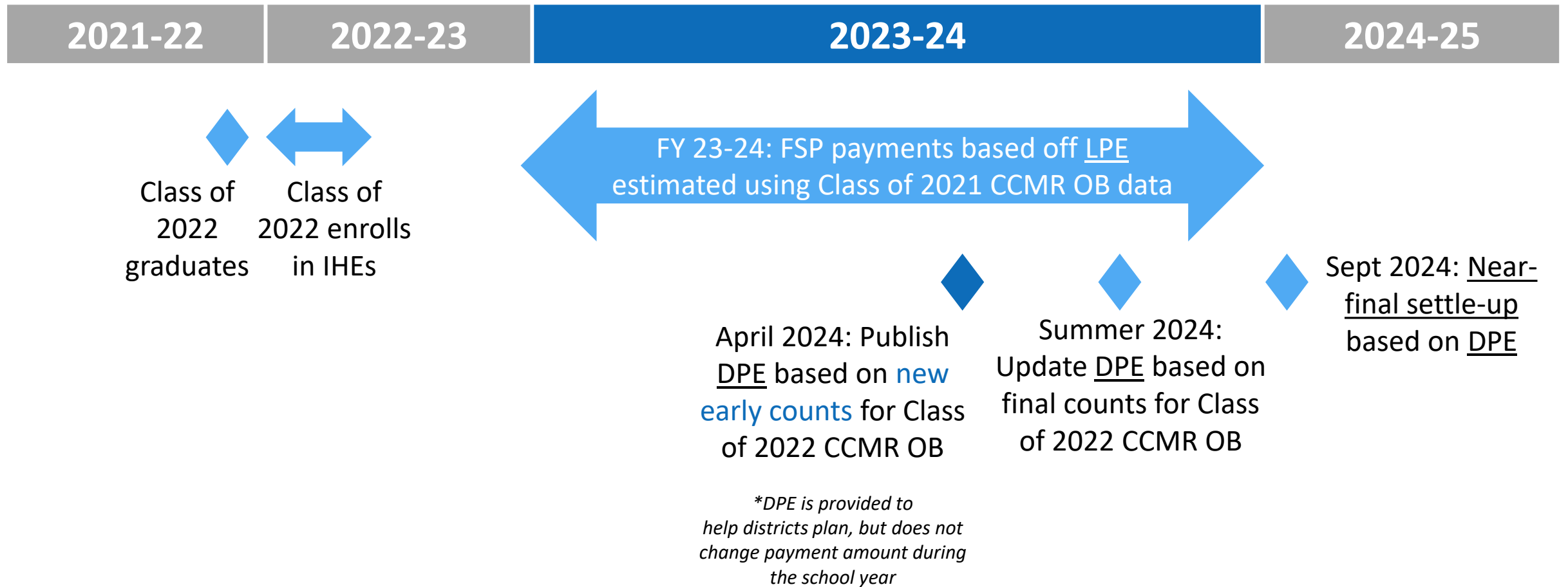
Career ready in CCMR OB is defined as:

- Meets Texas Success Initiative (TSI) criteria, and
- Earns an industry-based certification (IBC) or earns a level I or level II certificate

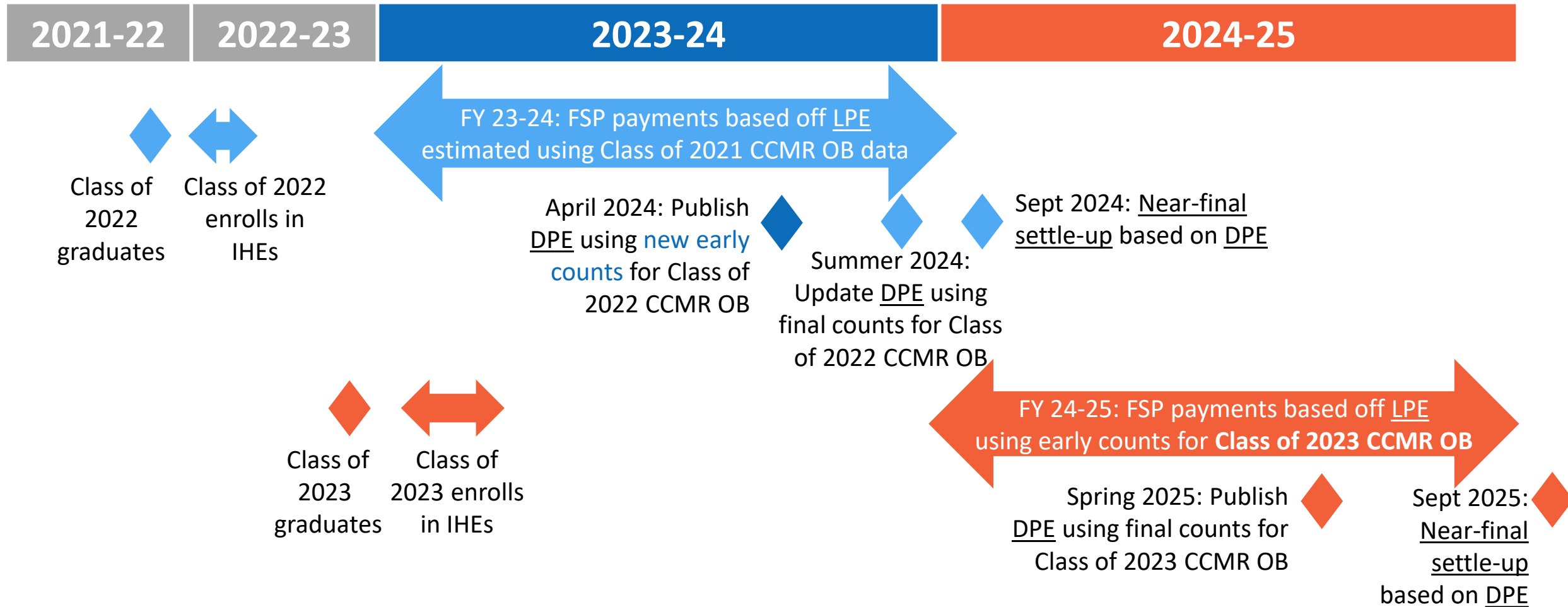
Current state: CCMR OB funding is estimated using data from previous years and is settled up at the end of the year



Updates for this year: New Early Counts gives districts a better estimate of funding for FY2023–24



Future State: New Early Counts allows future payments to be based on actuals rather than estimates



Note: DPE is provided to help districts plan, but does not change payment amount during the school year

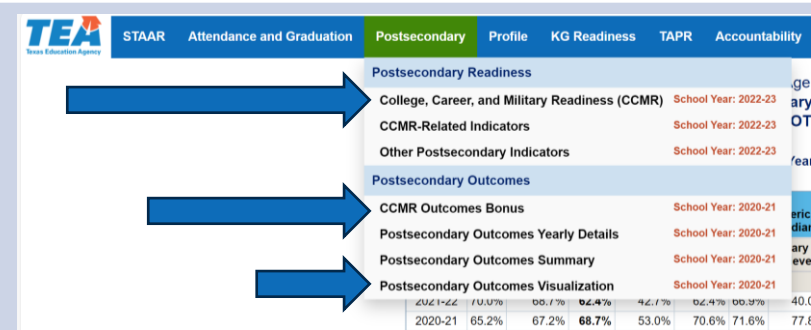

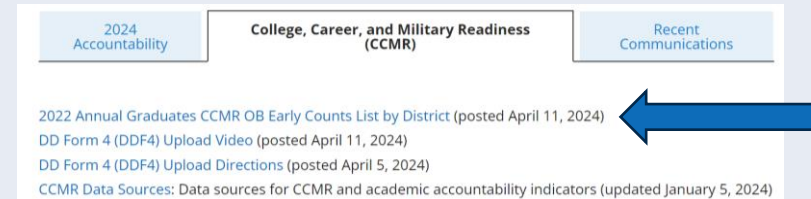
